Sustainability management



Management of sustainable development is handled by relevant functions and units at the level of the Company's Corporate Center in Moscow with further cascading down to the production sites' level.

The Company's Sustainability department is established in early 2019, to be followed, in mid-2019, by the Committee for Ecology, Sustainable Development and Social Investments. The Committee will report to the Management Board and coordinate the Company's activities in the relevant areas. The new Sustainability department will become the Company's joint coordination center for its sustainability activities, lead SIBUR's climate agenda, and drive the transition to circular economy.


